SPECIFICATION 2: In that Private First Class Corey R. Clagett, U.S. Army, did, while traveling in a vehicle between Forward Operating Base Brassfield-Mora, Iraq and the U.S. Army Criminal Investigation Command (CID) office at Contingency Operating Base Speicher, Iraq, on or about 29 May 2006, wrongfully endeavor to influence the testimony of Private First Class Bradley L. Mason as a witness in the investigation into the shooting of three male detainees of apparent Middle-Eastern descent whose names are unknown at or near the Muthana Chemical Complex on or about 9 May 2006 by communicating to the said Private First Class Bradley L. Mason a threat, to wit: "Staff Sergeant Girouard will not have to kill you because I will kill you if you say anything" or words to that effect.
