This court will be held at the offices of WISE International, 6331 Hollywood Blvd, Suite 701 Los Angeles, CA 90028 on Monday, January 29 1995. The Court Officer will be Mike Kobrin.

# COMMITTEE OF EVIDENCE

# FINDINGS AND RECOMMENDATIONS

## Craig Wiren, Public

Craig Wiren of Seattle, Washington has requested a Committee of Evidence to look into his suspension from training at Seattle Foundation Church of Scientology in February 1991.

A time track of events has been assembled here to give a better view of Craig's situation.

In December 1980, Craig started his first service at Portland mission. He took Church services on and off until 1985 at which time it was discovered that Craig had been institutionalized for a two-week period in 1980 and had taken psychiatric drugs at that time. Craig had also spent one week in 1980 attending a squirrel group known as "Lifespring".

In 1987, Craig received approval from a terminal in Snr C/S Int Office on a petition he had written to continue auditing. This petition approved for Craig to receive auditing on a co-audit basis while he trained on his Academy Levels.

In 1987, it also came to light that Craig had not paid any personal income taxes since 1982. Craig claimed at that time (and still maintains this view) that he was within his constitutional rights not to pay personal income taxes.

In 1991, while Craig was a student at ASHOD, he was reported to ethics by another student for his involvement in the non-payment of personal income taxes mentioned above. He was given a program to do by a Church attorney which included a security check. Craig was in disagreement with this program and he left LA for Seattle in February 1991. For a period of about one year while living in Seattle, Craig promoted the idea of "untaxing" (a method of avoiding payment of personal income taxes) to several Scientologists, including org staff within the Seattle Church. He distributed booklets which provided information concerning this practice via the org's comm system.

In June 1991, a Non-Enturbulation Order was issued on Craig for refusing the sec check ordered by the Church attorney mentioned earlier and for attempting to promote "untaxing" on org 'ines. He was suspended from training at Seattle Org at this time because of his unresolved involvement in "untaxing" and his disputed non-pay int of personal income taxes. A year later he was denied training "Steven's Creek org for the same reason.

Craig was given a Committee of Evidence at Steven's Creek org in 1992 concerning his involvement with "untaxing" but the Findings and Recommendations were never published.

Throughout the time period of 1991 to 1995, Craig has been ordered by Church officials to stop the practice of "untaxing" (in other words, pay the personal income taxes required by law to the IRS). Craig has been unwilling to do this.

He was called to LA for his second Committee of Evidence in January 1995 at his request.

After careful review of the evidence assembled, the Committee's Findings and recommendations are as follows:

## **ECCLESIASTICAL CRIMES:**

1. PLACING SCIENTOLOGY OR SCIENTOLOGISTS AT RISK.

Craig pleaded not guilty. The Committee finds Craig guilty of this charge.

In reviewing evidence concerning the practice of "untaxing", it can be seen that there is risk for those involved.

"Untaxing" involves a complicated system of redefining words to mean something other than intended in order to find a way around the law.

Craig admitted that he has carefully studied the Internal Revenue Code which states who must pay personal income taxes. He claims that he fully understands these laws.

However, his whole legal stand against payment of personal income taxes and the only justification for not doing so is based upon his believing that he is NOT required to pay. He claims that because he has written testimony from an accountant and a lawyer that he is not required to pay personal income taxes, then this makes him exempt.

Yet the IRS Code which is the source of the law states that one must pay personal income taxes. Craig has chosen to believe the accountant and attorney and ignore what the law has stated as these align with his own purposes in the matter and the law does not.

In 1973 LRH wrote, "A country has laws and regulations to coordinate its activities. One does NOT seek to get around these or avoid these or find loopholes in them. That is COMPLICATED AND DISHONEST. It is MUCH simpler just to know them and obey them."

Additionally, Scientology Policy Directive of 2 May 1994 PERSONAL INCOME TAXES states that "...a Scientologist who refuses to file a tax return, to pay required income taxes, or to comply with other tax laws, is in violation of the Scientology ethics codes and by his or her unethical conduct is placing himself and the group at risk. Such a person will be ineligible for Church services until the matter is rectified."

2. OMISSIONS OR NONCOMPLIANCE REQUIRING HEAVY INTERVENTION BY SENIORS CONSUMING TIME AND MONEY, WITH DEV-T.

Craig pleaded not guilty. The Comm ee finds him guilty.

In February 1991, Craig was ordered the Litigation Prevention Officer OSA US to complete an HCO Sec Che which he refused to do. In September 1992, he was again ordered to collete his program to sort his situation out. In August 1994, he was again told by the ED Seattle Foundation that he would not be accepted in training until he showed evidence that he was filing income taxes per the law. Craig has not done this.

Also, in February 1991, after he was given the program by the Litigation Prevention Officer OSA US, he returned from LA and attempted to get back on service lines at Seattle org without having completed the above program. He also attempted to get on lines at Stevens Creek Org. In both cases he had to be ordered to complete the program originally given to him by the Litigation Prevention Officer in 1991.

# ECCLESIASTICAL HIGH CRIMES:

1. CONTINUED MEMBERSHIP IN A DIVERGENT GROUP.

Craig pleaded not guilty and the committee concurs. There was no evidence to uphold this charge.

2. FAILURE TO HANDLE OR DISAVOW AND DISCONNECT FROM A PERSON DEMONSTRABLY GUILTY OF SUPPRESSIVE ACTS.

Craig pleaded not guilty and the committee concurs. There is no evidence to show that Craig has been connected to anyone demonstrably guilty of suppressive acts.

3. VIOLATION OR NEGLECT OF ANY OF THE TEN POINTS OF KEEPING SCIENTOLOGY WORKING....

Craig pleaded not guilty. The Committee finds him guilty.

Per knowledge reports from Scientologists with whom Craig has been in personal contact, Craig had expressed fears of being investigated by the IRS for his non-payment of personal income taxes and on one occasion he stated that if an IRS agent did attempt to break entry into the house, "I'd use my gun and if necessary shoot." He was living in a house with other Scientologists at the time.

As evidence by the above, and other data available in Craig's ethics files, he has been refusing to pay personal income taxes required by law for over a decade. In 1991, he was suspended from training at ASHO until he handled the situation of not filing income taxes. In the same year, he was again suspended from training at Seattle Org for the same reason. In 1993, he was refused service at Stevens Creek Org. Heedless of the urgings from Scientology executives and staff members, Craig continued refusing to file personal income taxes, thus blocking his own progress up The Bridge. He has refused to get ethics in on himself and has therefore demonstrated a refusal to apply the first technology of Scientology - ETHICS TECHNOLOGY. The Committee therefore finds Craig Wiren guilty of neglect of point five of Keeping Scientology Working - "Applying the technology." - LRH

### ADDITIONAL FINDINGS:

In 1991, Craig confessed to another Scientologist that he felt he was being hounded by Zionists and the CIA. He has stated that he felt that his phone was bugged. In September 1991, when an angry neighbor banged on his front door, Craig forbade another Scientologist from opening it, stating that he feared it was the CIA and instead called the police. After this incident, he fled his home for several days to stay at his brother's house, leaving notes on how to deal with the phone tap for the others who were living there.

Such behavior as that above shows that Craig is living in fear of investigation and of suppression from government agencies.

Craig has been given plenty of opportunity to confront his condition and make ethics change. Instead, he has perpetuated his situation by refusing to get honest with himself and the IRS.

Evidenced from the data given above, his actions have placed Scientologists with whom he has dealt at risk as he is liable to prosecution from the US government for his refusal to pay personal income taxes and the money he has loaned out or donated to Scientologists and Scientology activities may be subjected to collection by government or other agencies.

### **RECOMMENDATIONS:**

The Committee therefore recommends the following:

- 1. That Craig Wiren be assigned a Condition of Confusion.
- That Craig Wiren be forbidden to receive training or processing of any kind from any Church of Scientology until he has fully paid all money required by US law to the IRS.
- 3. That before Craig is permitted to resume services at any Church of Scientology, he is to receive full 'earance to do so by the Office of Special Affairs International.

### EXECUTIVE COURT OF ETHICS

### MISSION HOLDER CAPITOL - ROHN WALKER

- An Executive Court of Ethics is to be convened on Mission Holder Capitol in Sacramento, Rohn Walker.

In February 1994, a letter was sent to Rohn from the CO SMI International informing him that all US Missions are electing back into the Federal Insurance Contributions Act (FICA) and that therefore withholdings of social security taxes had to be made. It has just been found out that despite repeated nudges to comply to the above, Rohn is still in noncompliance with this order, which is a violation of applicable laws.

In March 1994, Rohn was informed that he needed to submit evidence by 1 June 1994 showing that his Mission had all the requirements in for tax exemption status. This TM was not met and in the first week of June 1994, Rohn was reprimanded by issue by the DSA SMI Int and then he promised to get this handled right away. He also originated to the DSA SMI Int and Tax Compliance Officer OSA Int doing lower conditions based on the outnesses found and dev-t caused, but not one formula has as of yet been received at SMI Int for review and approval for upgrade. Neither has his tax exemption routing form.

The Mission is operating in an unviable range. Per LRH™ ED 340R INT, 1982/83 MISSION BIRTHDAY GAME, it is the role of Missions to flood their communities with books and to drive people onto The Bridge® so that they can go up the line to Clear. Over the last six months, Capitol Mission has sold only eight books to new public, started ten new public on services and sent ten public to the Org.

Rohn is therefore charged with the following:

Any Certificates or Awards Paul Attencio may have been issued are cancelled.

Any trademark licenses that Paul may have signed are also hereby cancelled, and he may not use the marks in any manner whatsoever.

It is hoped that he comes to his senses and seeks the mercy that the Church offers. Should this occur, he is to do the A to E steps as covered in HCO PL 23 Dec 1965RB, SUPPRESSIVE ACTS, SUPPRESSION OF SCIENTOLOGY AND SCIENTOLOGISTS.

## SUPPRESSIVE PERSON DECLARE ANISSA ARNOLD

Anissa Arnold, former HCO Director of the Buenaventura Mission is hereby declared a Suppressive Person.

Anissa blew staff in Nov. 93 and failed to return within a reasonable length of time in violation of HCO™ PL 7 Dec 76, LEAVING AND LEAVES.

Prior to her blow, Anissa was being investigated due to the severity of the financial irregularities and false reports she had committed.

Her false reports included not entering in the checkbook at least three credit card "charge backs" (which were deducted from the Mission's accounts by the bank) totalling approximately \$7,698.00. This gave a false idea of what the Mission had in accounts and also caused Mission checks to bounce which resulted in bad public relations between the Mission and its creditors.

Anissa admitted to taking in excess of \$5,000.00 from the Mission by taking money from the cash box and by receiving money from public but not invoicing it.

To cover up these financial irregularities she charged unauthorized purchases to two publics' credit cards, in violation of church policy, totalling approximately \$5,000.00, creating upsets with the public and intentionally entering incorrect balance amounts in the Mission's checkbooks.

Anissa knowingly withheld the above from her seniors and led them to believe that there was more money in the Mission's accounts than there really was. She also withheld that there were checks that had

By her own admission she has false reported statistics on promo out, Bulk Mail Out, Letters Out and Qualified Staff Hired.

By committing the aforementioned acts, Anissa has shown herself to be guilty of the following Suppressive Acts (the first two are ecclesiastical crimes that have been reclassified as Suppressive Acts due to their magnitude and severity):

- EMBEZZLEMENT.
- 2. JUGGLING ACCOUNTS.
- ANY FELONY (SUCH AS MURDER, ARSON, ETC.) AGAINST PERSON OR PROPERTY.
- FALSIFYING RECORDS.
- SEVERE BREACH OF ECCLESIASTICAL AND/OR FIDUCIARY DUTY AS AN EXECUTIVE OR CORPORATE OFFICIAL OF ANY SCIENTOLOGY® OR DIANETICS® ORGANIZATION WHICH AS RESULTED IN SEVERE HARM, LOSS OR DISREPUTE FOR SCIENTOLOGY OR THE ORGANIZATION.
- BLATANT AND WILLFUL OBSTRUCTION OF CHURCH OPERATIONS OR INTERFERENCE WITH CHURCH CONTRACTUAL AND OTHER OBLIGATIONS TO THE DETRIMENT OF CHURCH EXPANSION OR ACTIVITIES.

Any certificates and awards she may have earned are cancelled. trademark license she may have signed is cancelled and she has no right to use the materials of Dianetics and Scientology.

Should she come to her senses and wish to seek the mercy offered by the Church, Anissa is advised to follow steps A through E of HCO PL 23 December 1965RB, SUPPRESSIVE ACTS, SUPPRESSION OF SCIENTOLOGY AND SCIENTOLOGISTS. Her only terminal in Scientology is the International Justice Chief via the Continental Justice Chief.

# EXECUTIVE COUNCILS AUSTIN DAY AND FOUNDATION FLAGSBANKING OFFICERS AUSTIN DAY AND FOUNDATION

The Executive Councils and the Flag Banking Officers for Austin Day and Austin Foundation orgs are hereby assigned the condition of Treason.

IMEC Program Order 199 FBO/TREASURY PREPARATION FOR COMPUTERIZATION 339R program was issued to get orgs to handle any backlogs in both their treasuries and the Finance Offices and get these records fully in compliance with OEC Volume 3 references.

Despite repeated telexes to the orgs' FBOs to get this program into execution and start getting standard policy being applied in the orgs, the program has not been executed as evident in the lack of compliance reports sent in on the program or dones reported. One example of not getting in standard policy is the org's refusal to open two of the three standard FBO Accounts.

It is noted that the orgs are not moving their dateline as well as false reporting its dateline which in fact is the oldest in the cont.

The treasuries of these orgs are completely unmanned, with no one taking full responsibility for the finances of the org.

The Executive Councils are assigned the condition of Treason, due to the insolvency of the org and their failure to ensure that standard LRH policies are being applied to their orgs with regard to treasury and finances, this includes the manning up of treasury so that standard records are being kept.

The neglect and failure of getting IMEC Program Order

199 done and getting the areas manned with competent personnel who will then get LRH policy being applied 100% in treasury endangers the tax exemption status of Scientology.

Therefore, the Executive Councils and the Flag Banking Officers are assigned the condition of Treason for hats not wearing.

Executive Council Austin Day and Austin Foundation as Executive Councils and the Flag Banking Officers Austin Day and Austin Foundation have 24 hours to get through this assigned condition.

DAVID MAYO is hereby Declared a SUPPRESSIVE PERSON and EXPELLED from the Church of Scientology.

Thorough investigation by qualified Church ministerial personnel and senior Church Officials has proven conclusively that Mayo perpetrated and conducted numerous off policy activities and highly squirrel technical procedures. David Mayo is labelled a squirrel.

It is to be noted at the outset that Mayo over the years constantly presented himself as beyond reproach while maintaining a cloistered removed relationship from fellow staff and executives.

He classically would seek to impress one with his professed level of case and technical training to specifically avoid taking ethical responsibility for outnesses in his zones of responsibility.

"INSANITY IS THE OVERT OR COVERT BUT ALWAYS COMPLEX AND CONTINUOUS DETERMINATION TO HARM OR DESTROY.

"Possibly the only frightening thing about it is the cleverness with which it can be hidden." (HCOB 28 Nov 70 C/S Series 22)

In these ways Mayo was able to keep specific details of his actions from direct view for some time while false reporting blatently on his activities. It was not until an accumulation of serious non-compliances was found committed by him directly as regards to the handling of a specific out-tech matter and area that his true nature, productivity, and suppressive acts were fully revealed.

Subsequent investigation first brought to light that Mayo engineered the reinstatement of a highly dangerous auditor (declared SP Paulette Cohen). This person was directly responsible for the infamous "List 1 Project" in the late 70's which labelled literally hundreds of well meaning staff and public falsely as "List 1 R/Sers" and "Suppressives".

For this Cohen had been forcibly removed from any and all technical lines forever. Her severe infractions of the standard technology of Scientology were blatent and documented many times over.

Despite her gross auditing errors, severe and disreputable code breaks, squirrel application of technical rundowns, and clearly false reports time and time again in worksheets, Mayo over a two year period worked steadily to position this person back

onto technical lines where she once again committed serious squirrel technical procedures on key staff members at senior level

Mayo himself personally acted as the Case Supervisor for these cases while SP Cohen squirrelled horribly under his direction and approval.

Inspection of PC folder programs by qualified ministerial personnel found Mayo to be making up his own processes (including "NOTS" processes), mixing rundowns (picking out of context random "OT and NOTs" procedures and mixing them into programs for lower level preclears), failing to clear all rudiments prior to starting auditing processes, and cleverly wording programs designing them to evaluate and invalidate not only the PC's gains but also their current level of case. This latter was accomplished by Mayo "brightidea" squirrel processes which would enforce wrong items upon a PC.

"...a squirrel is doing something entirely different. He doesn't understand any of the principles so he makes up a bunch of them to fulfill his ignorance and voices them off on a pc and gets no place." (Ref: SH Spec 77, 6111C08)

For instance, Mayo would "innocuously" slip in calculatedly worded "2WC Questions" to drive the PC into his case with wrong items in hopes that both the auditor and PC would then remain beholden to him and his "special case supervision". Mayo would incessantly try and manipulate himself into a position where he would be considered indispensible to accomplish a resolution of the preclear's case—a case he previously went to great lengths to sabotage with squirrel procedures thus creating the apparency of a "dog PC" who required his "expertise" to C/S.

Thinking he was then holding both the auditor and PC fully dependant upon him and not LRH technical procedure Mayo would cleverly invalidate the auditor's training on Source HCOBs (as to achieve results now necessitated his know-best squirrel supervision).

The above violations of HCOB 28 Sept 82 C/S Series 115 MIXING RUNDOWNS AND REPAIRS and the very purpose of auditing were done by Mayo to suppressively increase his own self aggrandizement and to prevent others from achieving upper level training class and states of case which might then endanger his own livelihood and status.

"RULE FOUR: ALWAYS C/S the pc for his own gain, not for any other purpose. The purpose of auditing is to help the pc, not to remedy social or organizational ills. If this is followed, those same ills vanish. If this is not followed, the ills multiply. The purpose of auditing is to help the pc become more able as a being and has no part of discipline or 'getting even'."

"RULE TEN: All C/Ses and Auditors are trusted beings. They earn that trust by being very standard. When they depart from standard tech, when they mix up RDs or repairs, they betray that trust, the pc and themselves and block the way to a better being and far better universe. (HCOB 28 Sept 82 C/S Series 115 MIXING RUNDOWNS AND REPAIRS)

Ron Hubbard ALL RIGHTS RESERVED wife's auditor to enforce these processes upon his wife and would keep the PC folder under lock and key refusing to have it reviewed by an outside technical terminal for correctness. It is of note too, that Mayo nimself was "interested" in another woman—who happened to be his wife's very auditor who he put onto the case. While the wife was in tears asking "her C/S" to please sort out the second dynamic troubles out of session with a Chaplain or Ethics Officer, Mayo (the C/S) refused and just continued enforcing his brand of processing on the PC over an obvious ethics situation and physical universe present time problem.

His handling of this one case exemplifies a number of "horror story" case handlings Mayo busily worked at by way of squirrel auditing procedures.

You can always tell a squirrel because both his advice and his Pcs don't get better.

In another instance of David Mayo's suppressive campaign, surveys were conducted on roughly 400 staff under his personal care as the ex-Snr C/S Int finding that during a 2 year period only a small handful had been allowed by Mayo to progress on standard Grade Chart auditing actions—the rest being subjected to numerous Mayo "pilot research processes", squirrel repair actions, evaluative and invalidative squirrel forms of "security checking", or left bogged labelled "dog cases".

"There are no dog cases, no 'ncgs', no failed cases."

"The source of out tech is only laziness and dishonesty.... Don't be a psychologist or psychiatrist. That was their route."

(Ref: HCOB 26 Oct AD25 C/S Series 95 "FAILED" CASES)

Mayo literally is the "Darling of the psychs".

Only personnel within his own personal office and several related technical staff working directly for Mayo had been programmed for and allowed to progress on routine Grade Chart auditing.

Also in this staff area, Mayo ran a Qualifications Bu which was found committing gross auditing errors and numerous squirrel technical procedures. These actions were being run, C/Sed, and monitored directly by Mayo who held himself as beyond reproach, heavily invalidating anyone questioning the validity and standardness of these squirrel dealings.

Here again was found the Mayo "bright-idea" squirrel processes and case programmings not the least bit similar to standard LRH tech.

When approached to submit to standard cramming and correction on out tech being discovered, Mayo would refuse or attempt to excuse away the out tech with made up stories presented to dodge simply confronting the fact that he was not so "perfect" and did indeed require correction.

With these and other obvious crimes found, an indepth survey and investigation was conducted to spot and locate where David Mayo had impeded the route to OT for public Scientologists and such were indeed found:

In the area directly under his care as Snr C/S an unparalleled percentage of staff and executive failures occurred.

"The SP is sure everyone is against him personally and if others became more powerful they would dispose of him." (Ref: HCO PL 7 Aug 65 SUPPRESSIVE PERSONS, MAIN CHARACTERISTICS OF)

"The SP wants smaller, less powerful beings. The SP thinks that if another became powerful that one would attack the SP.

"The SP is totally insecure and is battling constantly in covert ways to make others less powerful and less able." (Ref: HCOB 5 Feb 66 S AND D WARNING)

The above and other squirrel activities were clearly visible in PC folders personally C/Sed by Mayo after his false reports and misassessments of the case were corrected and removed. Due to the severity of these actions by Mayo it is clear that his violations of standard Scientology technical procedures were deliberate and selectively committed based on ill founded and evil motives and prejudices held by him.

"The chaos merchant wants an environment to look very disturbing.... There are many who spend their whole lives as professional chaos merchants simply by worrying everybody around them to death. The percentage is probably one out of five. They spread confusions and upset. 'If I can just keep Henry worried enough, he does whatever I tell him.'" (Volunteer Minister's Handbook, Page 155)

Using a facade of good intentions and "serene" disposition Mayo charmed his way committing suppressive acts.

"The truly insane do not necessarily act insane visibly. They are not the psychiatric obvious cases who go rigid for years or scream for days. This is observed only in the last stages or during temporary stress.

"Under apparent social behavior the continual crimes knowingly committed by the insane are much more vicious than ever has been catalogued in psychiatric texts.

"The actions of the insane are not 'unconscious'. They are completely aware of what they are doing."

"All characteristics classified as those of the 'suppressive person' are in fact those of an insane person." (HCOB 28 Nov 70 PSYCHOSIS)

It was even found that Mayo, having long term upsets and conflicts with his wife (now divorced) C/Sed and programmed her for continued upper level squirrelled processing and mixed R/Ds in attempt to evaluate and invalidate her in hopes of "getting back at her" and to keep her at effect. He hand picked and coerced his

1. Mayo, acting on his own accord, was found to have removed the Professional TRs Course from its proper position on the training line up per the Grade Chart. Though now rectified, this one action by Mayo stands as a most serious and potentially damaging action in that he effectively stopped standard TR training for auditors seeking to deliver the utmost in quality counselling. Many LRH HCOBs and lectures cover the absolute requirement of one's TRs being firmly in through rough tough drilling before being considered a valid certified auditor. By taking this Professional TRs Course away from auditors in training Mayo opened the doors to misapplication of standard auditing procedures.

As the ex-Snr C/S Int at the time, Mayo was fully and utterly responsible for the quality of technical delivery—throughout the world. By preventing auditors from training appropriately on TRs he acted fully contrary to the purpose of his post.

His action above clearly points out that Mayo failed to appreciate even the most fundamental of auditor basics proving that he himself never trained on TRs to full end phenomena. Had he done so, he would have had a conceptual understanding of the importance of TRs and the vital role they play in the standard delivery of LRH technology in Scientology and Dianetics.

- 2. When asked by Scientology Missions International (SMI) to review for standardness and assist in handling a suppressive squirrel process developed and being spread by ex-Mission Holder Kingsley Wimbush (de-dinging) it was Mayo who in actual fact sanctioned the squirrel procedure in a written communique in reply.
- 3. Mayo promoted that there existed "harmonics of Clear" down his lines to Case Supervisors in Orgs. This squirrel false "datum" is in itself a covert degrade of the state of Clear which stands alone as a singular state never even approached prior to Scientology. The fact that Mayo would even attempt to interpret the state of Clear in a way fully contrary to Source references is indicative of his own failure to honestly achieve this state.

Mayo followed suit by then issuing verbal tech and squirrel instructions to auditors and C/Ses encouraging them to compromise their reality and allow PCs who had achieved states of release to prematurely attest to Clear. This very destructive action by Mayo set numerous well intentioned Scientologists up for losses due to out gradient processes then being applied over a false Clear attest.

When it was adamently insisted he receive correction for his out-tech in this regard he refused to standardly clear his misunderstood words saying that the correction had "lowered his IQ" and "driven him near stupidity". He then proceeded to C/S himself for a squirrel version of an Effects of an R/Ser checklist to which he listed a number of hard working staff and executives and self-audited himself to clean up the "inval".

This self C/Sing and self-auditing is mentioned here as this is a severely squirrel out ethics activity—one not covered by the confidentiality of ministerial counselling nor a following of the Auditor's Code. It is blatently an ethics matter and not auditing. This "other practice" fully violates Source technical issues.

It was discovered that Mayo hand picked and manipulated his own auditor to carry out highly squirrel self C/Ses consisting of made up processes and mixed R/Ds which he would originate—refusing to pass his own PC folder to another C/S for standard Scientology technical programming and supervision.

It was also found that Mayo classically C/Sed and audited himself on motivators always avoiding his own responsibility and blaming others for his condition.

- 4. David Mayo, stating he was efforting to speed up training, attempted to stop Class VIII auditor trainees at the Advanced Organization in Los Angeles from properly studying their checksheet "three times through" saying that this datum was false and written by other than Source. Though caught and handled by others, it is of note that the Founder himself clearly states this requisite in his own voice on the very tapes one studies on the Class VIII Course.
- 5. In perhaps his most clever attempt to avoid his own transgressions, David Mayo engaged in a systematic campaign to knock out Scientology Ethics Technology. This is the body of LRH technology which for the first time in the history of man allows one to confront one's contrasurvival acts on any Dynamic and to rise above these to carry on up the Bridge to Full OT.

Mayo's efforts to degrade Scientology Ethics and limit its use stretches back years but it was only recently when he overtly lashed out at this incredibly valuable technology that the extent of his dealings were made known. During 1981 alone he cancelled outright a major ethics training checksheet giving no replacement, forbade a staff member from applying standard ethics technology to her life at which point she sought to leave, released two issues internationally labelling ethics tech as "eval and inval" and not to be done on preclears, labelled ethics technology as "an off line case action" and pushed down his lines to other Case Supervisors that they were not to use this technology, openly denigrated standard confessional procedure (processing where a preclear may seek relief and forgiveness for transgressions committed), and heavily pushed the grossly false data that one resolves ethics situations by putting the person onto the next higher Grade or OT level.

It was Mayo who took it upon himself to intervene and cancel a highly trained C/S's emphatic instructions disapproving now declared and expelled SP Bill Franks from being allowed onto NED for OTs.

6. It was Mayo too who personally acted as the Senior Case Supervisor for ex-GO executives now purged from the Church for criminal acts wholly contrary to the policy and mores of the Church which they then tried to cover up with false PF and mindless attacks.

Though Mayo professed the attainment of upper level OT states (and even misled others to believe that he had been privy to yet unreleased OT processes in an effort to further his status and notoriety) he in fact achieved not one of these states by his own admission just prior to his choosing to leave the Church having been confronted with the severity of his actions.

"SPs don't get case gains. Sometimes they pretend them. They are held back by their continuing overts. If we were found by them to be decent, their past conduct would swell up and engulf them." (Ref: HCO PL 7 Aug 65 SUPPRESSIVE PERSONS, MAIN CHARACTERISTICS OF)

"The APPARENT pattern of insane behavior is to come in (ask for processing, go on staff, etc) with the advertised intention of being helped or helping, then mess up either as a pc or on post, then state how bad it all is and leave. It looks obvious enough. He came, found it bad, left.

"That is only the APPARENT behavior. APPARENT REASONS.

"Based on numerous cases, this is the real cycle. Hearing of something good that might help these hateful awful rotten nasty people, the psycho comes in, wrecks this, upsets that, caves in this one, chops up that one and WHEN SOMEBODY SAYS 'NO!' the psychotic either

- "(a) Caves himself in physically or
- "(b) Runs away.

"The psychotic is motivated by intent to harm.

"If he realizes he is harming things he shouldn't he caves himself in. If he is afraid he will be found out, he runs.

"In the psychotic the impulse is quite conscious." (Ref: HCOB 28 Nov 70 PSYCHOSIS)

Mayo, the victim of his own out ethics and overts against others directly blocking their attainment of full OT clearly could not hope to achieve case gain. His choosing to leave staff and Scientology points out the fact that Mayo's regard for the true purpose of auditing and the miraculous results obtainable from the standard application of Scientology and Dianetics was nill. Well known now for his constant efforts to shift blame to others and to remain irresponsible for his own condition, he has been reportedly claiming all manner of "injustices" committed against him and natters profusely about those who finally brought his crimes to light.

It was additionally found that Mayo put together a "Pilot Mission" to run public and staff in a nearby area on technical courses he was "developing" and "researching". Mayo ran this group of unsuspecting individuals in such a way as to have them take Org public off their Org's lines, reg them to do his off-Source materials, and then forward the income made directly to him. Nearly \$39,000 was discovered hidden in a paper shoe box—the checks and cash invoices written directly to him. This is to be expected from a squirrel for:

"...We find their papers full of the materials which were hard won by myself and the central organizations and yet we have nothing but debits on our records to show that they passed our way. These people have as their major fault no cognizance of effort. These people also have given us ample experience of financial irresponsibility. People such as our best known 'squirrels' are perfectly willing to snatch our hard won materials and misuse them, but they are not willing to support the effort which brought these materials into being," (Ref: PROFESSIONAL AUDITOR'S BULLETIN 90)

The data above contains but a sampling of David Mayo's Suppressive sive Acts and squirrel procedures. As is typical for a Suppressive Person, Mayo worked coolly and calculatively engineered his Suppressive efforts. He would then couch them behind a false reputation he worked for years to establish. By neatly surrounding himself with a small handful of people manipulated as explained above, Mayo with a small handful of people manipulated as explained above, Mayo remained cloistered and individuated from others. He was then able to take advantage of his position's communications lines and resources to squirrel Scientology suppressively.

Mayo added arbitraries and stops to the route to OT. His acts covered above even in some cases required the Founder to issue corrections to Mayo's out-tech, squirrel false data and orders (see HCOB 7 Oct 82 C/S Series 114 Cancelled "KSW Series 28 Cancelled", HCOB 28 Sept 82 C/S Series 115 MIXING RUNDOWNS AND REPAIRS, and HCOB 13 Oct 82 C/S Series 116 ETHICS AND THE C/S).

Though the route to Full OT is exactly mapped by LRH, Mayo could always be found incessantly trying to alter it in an effort to achieve notoriety as a "source" of tech.

Lest there be any who may wonder, there is only <u>ONE</u> Source of the technology in Dianetics and Scientology - L. Ron Hubbard, Founder.

David Mayo is certainly no friend of those travelling up the Bridge to Total Freedom.

Numerous efforts were made to allow David the opportunity to get his own personal ethics in. Correction was offered. Later, in an act of benevolence, he was encouraged to partake of a well laid out program covering the most rudimentary basics of Standard Tech for correction purposes. Mayo refused them all though confronted in detail with specific points of out-tech, overts, and crimes. He did however state that he knew he should do the program, but stated that due to the severity of his overts, he was undeserving of the tech and would rather blow, so he could not commit any more overts against the group.

He has committed the following Suppressive Acts:

- 1. MUTINY.
- 2. RECEIVING MONEY, FAVORS OR ENCOURAGEMENT TO SUPPRESS SCIENTOLOGY OR SCIENTOLOGISTS.

- 5. SPREADING FALSE TALES TO INVALIDATE CLEARS.
- 6. SPREADING LIBELOUS AND SLANDEROUS STATEMENTS ABOUT THE ALLEGED BEHAVIOUR OF CLEARS.
- 7. SEEKING TO SPLINTER OFF AN AREA OF SCIENTOLOGY AND DENY
  IT PROPERLY CONSTITUTED AUTHORITY FOR PERSONAL PROFIT,
  PERSONAL POWER OR TO "SAVE THE ORGANIZATION FROM THE HIGHER
  OFFICERS OF SCIENTOLOGY".
- TOLERATING THE ABSENCE OF, OR NOT INSISTING UPON STAR-RATE CHECKOUTS ON ALL PROCESSES AND THEIR IMMEDIATE TECHNOLOGY AND ON RELEVANT POLICY LETTERS ON HUBBARD GUIDANCE CENTER INTERNS OR STAFF AUDITORS IN THE TECHNICAL DIVISION OR STAFF AUDITORS OR INTERNS IN THE QUALIFICATIONS DIVISION FOR THE LEVELS AND ACTIONS THEY WILL USE BEFORE PERMITTING THEM TO AUDIT ORGANIZATION PRECLEARS AND ON SUPERVISORS IN TECHNICAL AND QUALIFICATIONS DIVISIONS WHO INSTRUCT OR EXAMINE OR FAILING TO INSIST UPON THIS POLICY OR PREVENTING THIS POLICY FROM GOING INTO EFFECT OR MINIMIZING THE CHECKOUTS OR LISTS.
- 9. PUBLIC DISSEMINATION OF FALSE OR FORBIDDEN OR DANGEROUS DATA.
- 10. TO PERVERT TECHNOLOGY OR PREVENT DISCOVERY OF WITHHOLDS.
- ACTING IN ANY WAY CALCULATED TO LOSE THE TECHNOLOGY OF DIANETICS (SPIRITUAL HEALING TECHNOLOGY) AND SCIENTOLOGY (APPLIED RELIGIOUS PHILOSOPHY) TO USE OR IMPEDE ITS USE OR SHORTEN ITS MATERIALS OR ITS APPLICATION.
- 12. FAILURE TO HANDLE A PERSON DEMONSTRABLY GUILTY OF SUPPRESSIVE ACTS.
- 13. GROSS VIOLATIONS OF HCO PL 7 Feb 65 KEEPING SCIENTOLOGY WORKING. (The following crimes have been reclassified as HIGH CRIMES.)
- 14. USING SCIENTOLOGY HARMFULLY.
- 15. ISSUING THE DATA OR INFORMATION OR INSTRUCTIONAL OR ADMINISTRA-TIVE PROCEDURES WITHOUT CREDIT OR FALSELY ASSIGNING CREDIT FOR THEM TO ANOTHER.
- 16. FALSIFYING A COMMUNICATION FROM HIGHER AUTHORITY.
- 17. HOLDING SCIENTOLOGY MATERIALS OR POLICIES UP TO RIDICULE, CONTEMPT OR SCORN.

David Mayo is therefore DECLARED a Suppressive Person and EXPELLED from the Church of Scientology. Any and all certificates he may have held (both training and processing) are hereby CANCELLED.

He is debarred from future services and may not enter any Scientology organization or group. He is advised to consult HCO PL 16 May 1980 II ETHICS SUPPRESSIVE ACTS SUPPRESSION OF SCIENTOLOGY AND SCIENTOLOGISTS, page seven, section entitled EXPULSION.

David Mayo's only hope for mercy and for a path to travel out of the oblivion he has resigned himself to is contained in the above Policy Letter.

Any Scientologist found to be maintaining a line with, offering support to, or in any way granting credence to David Mayo and his actions or motives is also subject to declare and denial of any further services.

Recent investigation has uncovered numerous gross off-policy and off-Source activities conducted by Jon Stackelrodt as a staff member at Bridge Publications. As a Scientologist $^{\text{\tiny{M}}}$ , he is responsible for the proper application of LRH $^{\text{\tiny{M}}}$  Tech in all areas, including his work at this publishing company.

Jon was found by extensive investigation to have a long-term record of introducing squirrel proceedures on book sales lines which have blocked these lines and made it appear through false stats that noncompliance to standard proceedures in PUBS Base Orders was successful.

As the Direct Sales Manager Bridge Jon was found repeatedly falsifying his stats, damaging bookstore material, and accepting false commissions and pay.

He has a long history of financial irregularities and false reports on these lines, including setting up a squirrel invoicing system to facilitate writing false invoices with no purchase order approval.

Stackelrodt has taken bookstore items from Bridge's bookstore with no financial approval and gave these as awards to salesmen in order to gain higher stats for himself instead of utilizing standard Sales Manager tech on his post.

In several instances Jon Stackelrodt was found to have violated senior policy by making false promises of awards to salesmen and then never delivering what was promised.

In a series of instances Jon has further condoned that these "awards" were given away to public to create higher stats for himself. In an O/W write-up Jon revealed that he continued doing this knowing it was grossly off-policy.

In one instance it was found that Stackelrodt had ripped off another org for materials given as "awards" and never replaced the materials.

Awards games were misused to deliberately give out and promise completely out-exchange awards for production delivered. This was in effect an attempt to render bookstore materials less valuable.

Stackelrodt was also found to have debited a public's account without the consent of the public and was found to have misrepresented facts to public in order to make them buy - instead of applying standard sales tech.

As Sales Manager he has also condoned the off-policy sale of bookstore materials at cutative prices.

Jon Stackelrodt is charged with the following suppressive acts:

- 1. FALSIFYING RECORDS.
- 2. USING SCIENTOLOGY® LINES FOR PERSONAL PROFIT IN SUCH A WAY AS TO CAUSE DISRUPTION IN THE ORGANIZATION OR TO BLOCK THE FLOW OF PUBLIC UP THE BRIDGE®.

With this declare any and all certs and privileges Jon Stackelrodt may have been given by the Church of Scientology and any trademark licenses that he has signed with the Church are hereby cancelled.

His only terminal in Scientology is the International Justice Chief whom he may contact via the Continental Justice Chief.

Should Jon Stackelrodt come to his senses and recant, his only recourse is step A to E as covered in  $HCO^{\infty}$  PL 23 Dec. 1965RA, ETHICS, SUPPRESSIVE ACTS, SUPPRESSION OF SCIENTOLOGY AND SCIENTOLOGISTS.

## JANE KEMBER - PUBLIC ANNOUNCEMENT

Reference: HCO PL 7 March 1965, Issue II

JUSTICE - CERTIFICATE CANCELLATION

Step B (of A to E)

In January 1982, Jane Kember - former Guardian World-Wide was dimissed from staff of the Guardian's Office and her Certificates were cancelled, by WDC Conditions Order #4. Jane is now applying Steps A to E under the direction of the International Justice Chief, in accordance with the above LRH Policy Letter, to restore her Certificates and return to good standing as a Scientologist.

Per Step B of A to E. Jane wishes to make the following public announcement:

"While I held the position of the Guardian World-Wide I committed certain suppressive acts, for which I am truly sorry. The fact that this occurred was due to my having violated specific Church policies, as laid down by L. Ron Hubbard. My actions were ignorant and unfounded. This alteration of LRH T.M. policy stemmed from my own know-best. By violating policy, I endangered other Scientologists T.M. and created bad publicity for the Church. In fact, I brought about the exact things that I had been trying to avoid because I violated policy.

Within the Guardian's Office I also violated the ethics policies. In my view, this is the most significant factor because I never got to grips with the ethics policies, never handled my disagreements, and did not use them correctly on my juniors, the Deputy Guardians. Instead of using ethics, I used persuasion, "reason" and other mechanisms which became more and more burdensome. I violated policy and went off source.

The Deputy Guardians then became a protected group, and one only protects that which one has overts against. The other effect of this was that ethics was misapplied to the rest of the Guardian's Office, in that it was erratic and in some cases, unjust. I altered certain LRH policy into "In the Guardian's Office we do not do things that way'. What I was actually saying, which is clear to me now, is that in the Guardian's Office we do not use standard ethics policy, and thus we were splintered off from Scientology.

I actually had a major realization while writing this, that I actually and truly was off source and that the catastrophe that resulted was a result of being off source.

I have nattered about various higher officers in Scientology, specifically in the Sea Org. I have looked this over on my overts and witholds and I have realized what occurred. Through my failure to fully grasp the true purpose and intention of LRH's ethics technology, and my refusal to apply such standardly over a long period of time, I dramatized my disagreements with Ethics against the Sea Org whose primary purpose is to get in ethics. Thus the Sea Org missed the Withhold that I considered certain ethics policies to be unworkable and not to be used in the Guardian's Office, and I went wrong target. The true target is, in fact, those in Society who were and are attacking Scientology - these are the real enemies of all Scientologists, staff and public alike.

In summary, I have viewed many overts, motivations and other influences in relation to this, which were the result of the major overt of violating ethics policy. I have viewed them and handled my causation and motivation.

I fully intend to mend my ways and will cease to commit present time overts."

The Commanding Officer and HCO Executive Secretary of Valley org are assigned the condition of Treason.

In a recent inspection of the org's Treasury and Central Files area the following was found.

Central Files had been unmocked to the point of not being the least bit usable. The files had been thrown into a small cramped area, with boxes of kludge all over them. There is little to no space between the files to even file into the cabinets. Central Files is backlogged and there is no one taking any responsibility to get these files in PT and usable.

It was also noted during the inspection that the Addresso computer is set up in Treasury which is not a secure space, thus leaving the availability of the org's mailing list to anyone.

Adjacent to Central Files are the org's book stocks, this area as well is filthy and very kludgy, having the apparency of the book stocks just being thrown into the space. This acts as a denigration of LRH  $^{\text{TM}}$  materials.

"It is a high crime for any staff member to knowingly or unknowingly waste org book stocks or cause them to be wasted or tampered with.

"It is further a high crime for a staff member, Bookstore Officer or executive to fail to take the necessary precautions for the protection and correct use of org book stocks." HCO PL 23 DEC 1965RB (HCO DIVISION I) ETHICS, SUPPRESSIVE ACTS SUPPRESSION OF SCIENTOLOGY AND SCIENTOLOGISTS (OEC Vol 1, page 873).

In and amongst the book stocks are the treasury archive files, again these files have the apparency that they were just thrown into the area, having no organization at all.

The above named terminals also have 48 hours to get Central Files, the org's book stocks and the treasury areas dekludged and made usable.

The Commanding Officer and HCO Executive Secretary of the org have approximately 24 hours to get out of the condition of treason or further ethics gradients will be applied.
